ATTENDANCE DUES

Attendance Dues are a compulsory levy payable for all students who attend St Bede's College. The Attendance dues are collected by the Board of Proprietors to pay for maintaining and improving the Special Character of the College along with maintenance and upkeep of the school buildings and grounds. Attendance Dues do not qualify for a tax rebate.

FINANCIAL HARDSHIP

It is the policy of St Bede's College that all Catholic children should have reasonable access to a Catholic education. No one should be denied this right because of financial reasons. Therefore, families who cannot afford the Attendance Dues can apply for partial relief on the grounds of hardship.

Any hardship consideration is granted annually. If further consideration is required, subsequent applications must be made. Applications will be considered by a committee comprising of Rector, Deputy Rector (Pastoral), a representative from the College Financial Team and the Ministry Team Leader of the College.

CRITERIA FOR HARDSHIP RELIEF

- Loss of income/redundancy
- Death of a parent/caregiver
- Extended unemployment
- Hardship from other circumstances

APPLICATION PROCESS

For parents of prospective students, application should be made when enrolment is confirmed. For parents of existing students, applications will be accepted at the time circumstances change.
